The EU's emergency response to the COVID-19 pandemic as an overall crisis situation and the preparing of a coordinated EU Recovery plan overshadowed in 2020 and 2021 all other political objectives. Nevertheless the initial priorities of the new Commission, aiming to frame the EU political perspectives are still standing as benchmarks for political action. Most of them (a stronger Europe in the world, an economy that works for people, a new push for European democracy, promoting the European way of life) are comprehensive, broad priorities. Most concrete are the objectives towards a European Green Deal and a Europe fit for the digital age. Together they define the framework within which the Commission is acting.
